1. The credit balance, including interest, in favour of the Tenant booked on this rental deposit account is pledged in favour of the Landlord as security for all of the latter's claims against one and/or the other account holder arising out of the rental agreement between them.
2. Pursuant to the provisions of art. 257e CO, the Tenant and the Landlord can only dispose over the rental deposit account jointly or based on a legally valid order to pay or a legally valid court judgment.
3. Upon the rental agreement having terminated and the Tenant having complied with all obligations arising therefrom, the Landlord is obliged to release the account balance in favour of the Tenant and to deliver to the latter the attached duly signed release declaration.
4. If the Landlord has not made a legal claim against the Tenant within one year after the termination of the rental agreement, the Tenant may request from the Bank, against presentation of evidence, the repayment of the account balance.
5. The Bank is entitled to provide information regarding the rental deposit account both to the Tenant and the Landlord at any time during the entire term of the rental deposit account.
6. For opening a rental deposit account, Zuger Kantonalbank charges an opening fee of CHF 30, regardless of the amount paid into the rental deposit account.
