# Terms and conditions for retirement savings 3 and vested benefits

These terms and conditions apply to ZugerKB retirement savings funds and Swisscanto funds of the Investment Foundation held in retirement savings custody accounts of the Retirement Savings 3 pension foundation or Vested Benefits Foundation of Zuger Kantonalbank.

## Investment fee

The custody investment fees are calculated yearly as of 30 November on the basis of the average monthly custody account volumes. They are charged at the beginning of December.

## Note regarding balance compensation

An account with a negative balance after the deduction of the fees according to the valid Terms and Conditions is automatically compensated by corresponding sales of rights free of charge.
