Marcus Slöör appointed as a new member of the Executive Board of Zuger Kantonalbank

At its meeting today, the Board of Directors of Zuger Kantonalbank appointed Marcus Slöör as a member of the Executive Board and Head of Wealth Management. Slöör (50) has extensive leadership experience and an impressive track record in the wealth management area.

In his function as Head of Wealth Management, Marcus Slöör will be responsible for Private Banking, Wealth Services and for the bank's Investment Office. He will take up his new role on 1 June 2025.

Slöör has in-depth knowledge of the international financial industry and an extensive track record in the wealth management sector in particular. Most recently, he worked as a Managing Director in Wealth Management at Credit Suisse in Zurich, where he held the positions of Market Group Head UK International and Head of Shared Relationships Europe. Prior to that, he worked for several years in the bank's Private Banking division in Asia. From 2014 to 2018, he was responsible for the business with wealthy clients in Malaysia. Subsequently, he was appointed Head of Private Banking for Thailand and Vietnam, and in 2020 he was given the additional responsibility for the Philippines market.

Before moving to Asia, Marcus Slöör worked in Wealth Management at UBS for around ten years. Prior to heading up the Nordics region as Managing Director from 2012 to 2013, he held various positions in the Ultra High Net Worth Individuals (UHNWI) business for the Nordic countries, the UK and Switzerland. He started his career at UBS Investment Bank in London in 1999.

Hanspeter Rhyner, CEO of Zuger Kantonalbank, is looking forward to Slöör joining the Executive Board: "With his extensive track record and many years of international experience in the wealth management business, Marcus complements our management team very well. He brings a high level of understanding for the concerns of wealthy clients and will further develop our activities and our offering in this strategically important field. I wish him every success in his new position and look forward to working with him."

Marcus Slöör holds a Master in Law (lic. iur.) degree from the University of Fribourg and has completed various executive training courses. A Finnish citizen, he is married and has close ties to the Canton of Zug: he grew up in the Ägerital and graduated from Kantonsschule Zug in 1994. With his move to Zuger Kantonalbank, Marcus Slöör will relocate to the Canton of Zug.
